AT GOODWILL, WE BELIEVE IN GIVING A HAND UP, NOT A HAND OUT - A SAYING COINED BY GOODWILL'S FOUNDER, THE REVEREND EDGAR J. HELMS. HELMS WORKED AS A MISSIONARY IN THE SLUMS OF SOUTH BOSTON IN THE EARLY 1900S. HE HIRED THE POOR AND NEEDY TO MEND AND REPAIR USED GOODS HE COLLECTED FROM WEALTHY BOSTONIANS.
